Extension of time for renewing IAQ certificates issued under the Indoor Air Quality

Certification Scheme for Offices and Public Places to cope with the COVID-19 epidemic

(UPDATED)

According to para. 57(d) of "A Guide on Indoor Air Quality Certification Scheme for Offices

and Public Places" (2019 version), an application for renewing an IAQ certificate shall be

submitted to the Indoor Air Quality Information Centre ("the IAQ Centre") no later than three

months after the expiry date of the certificate, i.e. 3-months grace period. In view of the

COVID-19 epidemic, for IAQ certificates with their expiry dates on or after 1 October 2019,

the grace period was extended from 3 months to 9 months.

Given that the epidemic has receded gradually since early 2023, for IAQ certificates with their

expiry dates on or after 1 January 2024, the grace period for renewal applications will be re-

sumed to 3 months.
